The International ski trip in March is to Bad Gastein, Austria with an exciting post-trip to Munich & Prague. It's not too late if you act now! We will also have a summer international ski and adventure trip in August to Bariloche & Buenos Aires, Argentina with a pre-trip to Valle Nevado & Santiago, Chile and a post-trip to Iguaca Falls. The last planned trip for 2009 will be an exciting 10 day Scandinavia & Russian Cruise onboard the Princess Cruises' Emerald Princess with an exciting pre-trip to Copenhagen.


vacations this year.

# **Area Development**

Arizona Snowbowl. On 8/8/08 an 11 member en banc 9th U.S. Circuit Court panel in an 118 page decision ruled (8-3) in favor of Arizona Snowbowl based on a December 2007 rehearing of oral arguments for the Arizona Snowbowl snowmaking case. Judge Carlos Bea, writing for the majority said "A government action that decreases the spirituality, the fervor, or the satisfaction with which a believer practices his religion is not what Congress has labeled a substantial burden . . . on the free exercise of religious freedom. Were it otherwise, any action the federal government were to take, including action on its own land, would be subject to the personalized oversight of millions of citizens. Each citizen would hold an individual veto to prohibit the government action solely because it offends his religious beliefs, sensibilities, or tastes, or fails to satisfy his religious desires. Further, giving one religious sect a veto over the use of public park land would deprive others of the right to use what is, by definition, land that belongs to everyone. ...Respecting religious credos is one thing; requiring the government to change its conduct to avoid any perceived slight to them is quite another." This latest decision overturned the previous 3/12/07 9th U.S. Circuit Court three judge panel decision where Judge William Fletcher reversed U.S. District Court Judge Paul Rosenblatt's decision that Forest Service met all procedural requirements for approval of facility upgrades at Arizona Snowbowl and use of

reclaimed wastewater to make artificial snow. District Court Judge Rosenblatt had concluded that the goal of providing a reliable ski season was consistent with the Forest Service's multiple-use mandate. This case is one of the first legal challenges to the Religious Freedom Restoration Act of 1993 using the sacred site argument. This case sets an important precedent which extends American Indians the right to practice their religion in a way and to an extent the federal government deems appropriate and adequate on public lands (not Indian reservations) instead of protecting American Indians' religious rights as they themselves define those rights and the necessary circumstances for practicing their religions. This precedent could have a far-reaching negative impact on the current statutory multiple use doctrine (Federal Land Policy & Management Act) on federal lands with snowsports as a compelling use and potentially affect activity in a wide variety of locations including recreational areas such as ski resorts since about 60% of annual U.S. skier/snowboarder visits occur at ski areas on National Forest System lands. Ultimately in 2009 the Supreme Court is expected to decide to hear the case or let the Circuit Court ruling stand. See www.reclaimthepeaks.com for more info.

two years. With this triple net lease CNL will enter into a long term lease in September 2010

for Boyne Resorts to operate Big Sky Resort and provide Boyne with a buy back option. Boyne Resorts operates 7 other properties for CNL Lifestyle (Brighton Ski Resort, UT; Cypress Mountain, BC, CAN; The Summit at Snoqualmie, WA; Loon Mountain Resort, NH; Sugarloaf, ME; Sunday River Resort, ME; Gatlinburg Sky Lift, TN)

- Liberty Mountain Snow-flex Center scheduled to open March 2009 in Lynchburg, VA. This 110 vertical foot artificial year round snowsports incline will be the first in the U.S. surfaced with Snowflex, a synthetic material designed to simulate snow. Liberty Mountain with 40,537 square feet of skiable area will include a main ski slope, a beginner slope for ski and snowboard instruction, jumps, a tabletop, a big kicker, an 11-foot high quarter pipe, two grind rails and a tube chute.
- Stevens Pass, WA. Master development plan. Scoping letter June 2008, Environmental analysis decision Phase 1 Projects (water treatment system upgrade, five bike trails) expected May 2009, implementation August 2009. Mt. # **Exciting International Trips Coming Up**

Mary and I just returned from reviewing the Chile and Argentina sites for our August 2009 ski adventure. We were very impressed with the Chilean ski resorts. They are smaller than we are accustomed in the US, but they are still exciting. So now back home we are working like crazy preparing for Christmas, New Years and getting our far West international trips up-to-date. We think we have things back in order so here is our update.

On our October 2008 Greece Isles/Turkey trip, we sold out with 66 participants on the Greece portion and 41 going on to Turkey. Gloria Raminha was our assistant trip leader. She was of considerable help. The trip went as planned, except wind conditions prevented our ferry from Santorini going on to Miykonos. We spent an extra day on Santorini and an extra day in Athens. Everyone's favorite city was Istanbul and they all want to go back. The city has so much to see and the Turks are very hospitable.

We are now getting ready to leave for our FWSA Bad Gastein, Austria ski week with its Munich/Prague extension. Bad Gastein is a traditional health spa resort with a huge ski and snowboard area. We will fly into Munich and motor bus to Bad Gastein for the ski week. We will stay in Bad Gastein's ElizabethPark four star hotel, which is in the middle of town. For the second week extension, we will spend three nights in Munich and four nights in Prague. Debbie Stewart is our assistant trip leader. We are closed to new participants; however, we always seem to have last minute cancellations and will take matching replacements. We leave on February 27, 2009.

Our next ski trip will be this summer to Argentina/ Chile. This Ski & See trip (Aug 10 to 29, 2009) will start with a pre-trip extension to Valle Nevado, Chile. Valle Nevado is the newest Chilean winter resort; and is also the largest and most modern. Located 37 miles from Santiago; Valle Nevado boasts a skiable area of 21,600 acres and a 2,656-ft. drop. Together with La Parva and El Colorado-Farellones, these three ski centers form the largest skiing area in South America. After three nights and four days of skiing; we bus to Chile's capital city of Santiago with a three night stay at the Santiago Sheraton. Santiago is the centre of Chile's political, economic and cultural life. Its distinctive characteristics are the beautiful valleys, where the well-known Chilean wines originate. Santiago is nestled between high peaks with their winter sports centers and their coastline. Day trips to Portillo which is home to world

ski championship races and lies in a treeless amphitheater on the edge of a glacial moraine and Laguna del Inca. Located in the Andes, it reaches 19,000 feet and is located two and a half-hours drive from Santiago.

After Chile, those on the pre-trip will meet main trip participnats in Bariloche, Argentina's oldest and most famous ski area. The town has Alpine architecture and is known as the Little Switzerland of South America. The ski area consists of three side-by-side mountains located eight miles from Bariloche. There are forty miles of trails served by thirty-three lifts including a cable car. After 5 nights in Bariloche we fly to Buenos Aires, charming port city home of the Tango. It stretches south-to-north along the Rio de la Plata gateway to Argentina. You will see the Avenida de Corrientes (the nucleus of the Theater and nightclub district) which is the Broadway of Argentina. After Buenos Aires, it's home or off to an optional extension to Iguazu Falls, a massive array of over 200 separate waterfalls, a World Heritage Site It forms a border between Argentina and Brazil. We hope you can join us on the exciting summer trip.

FWSA North American and International Travel have contracted with *The Cruise Company* for a Scandinavia & Russia Cruise, September 13 to 23, 2009. It's a 10 day Baltic Sea voyage aboard the *Emerald Princess*. It includes an overnight stay in St. Petersburg and port stops in Copenhagen, Stockholm, Helsinki, Tallinn, Gdansk, and Oslo. A pre-cruise 3 night stay in Copenhagen is also available.

We are currently looking for a site for the FWSA's traditional international ski week for 2010. We will be requesting proposals from the industry shortly. If we don't contact a travel provider, that doesn't mean we are not interested in a proposal from them. We will be happy to consider any proposals they would like to present to us. Look for announcements on current and future trips on the Far West website www.fwsa.org.

On all our International trips, we accept all placements based on the order deposits are received by FWSA International Travel. It's very important to us that trips announced to Council presidents be sent to their clubs. # Ski & See Argentina & Chile

# Basic Bariloche & Buenos Aires Argentina, Aug 16-25, 2009

Bariloche is Argentina's oldest famous ski area. The town has Alpine architecture and is known as the Little Switzerland of South America. The ski area consists of three side-by-side mountains located eight miles from Bariloche. There are forty miles of trails served by thirtythree lifts including a cable car.

- 2007/2008 season was up 9.1% to 60.5 million skier/snowboarder visits (a 7.0% increase from the past 10 year average of 56.16 million visits) due to strong increases in snowfall in most areas (Pacific West +61%, Rocky Mountain +45%, Midwest +34%, Northeast +28%, Southeast -6%) according to the annual Kottke National End of Season Survey final report from NSAA.
- Rossignol Group wintersports (Rossignol, Dynastar, Lange, Look & Kerma brands of ski equipment & apparel) was sold by parent company Quicksilver Inc. which had purchased the group in March 2005. Sale to Chartreuse & Mont Blanc (headed by former Rossignol CEO Bruno Cercley closed November 2008 for 40 million euros/about \$51 million which was down from the 100 million euros/\$127 million offer in August 2008.
- FIS World Cup races available live and as VOD (video on demand) at www.universalsports.com.
- The Ski Channel cable television network to launch on 12/25/08 with Warren Miller films & tv shows to 15 million households plus DirectTv & Verizon FiOS TV. I couldn't resist an article in the Economist in

their December 20th edition titled, Cheap Skiing, Slippery Slopes. "America's 481 ski resorts did very well last year. At least 10% more visitors came than in 2006.

Record snowfalls attracted snow bunnies (novice skiers), buttdraggers (novice snowboarders), shredders (accomplished snowboarders) and rippers (accomplished skiers). This year, though, is not looking

anything like as good, at least for the fancy resorts out West. Snow levels are down in the Rockies, but the big problem is the economic storm."

"Vail Resorts, which owns four resorts in Colorado and one on the California-Nevada border, recently announced losses of \$34.5m. Its advanced bookings are down 23% from a year ago." "The Westerners are not about to give up. Lake Tahoe in California.... which relies less on airborne customers is in better shape to weather the frigid economic conditions. Some resorts are giving away free lift-passes, and others are offering a third or fourth night of lodging free. Regardless of the state of the economy skiers still enjoy the slopes. Just not as lavishly as they used to."

Jordan, who ranked top ten in all four disciplines during her first J-3 year, thanked the association for the scholarship and laid out her goals for the 2008-2009 competitive season. Her coach, Nils Ericksson, has praised her for her positive attitude and dedication, qualities that were very apparent in her speech.

Jordan very much typifies the special qualities we look for in a scholarship recipient.

As we look to 2009, we face some new challenges, but we know these challenges are surmountable and that the Far West spirit will prevail. #### SURVIVING A REALLY BAD SKI DAY!

My wife, Peggy, and I went to Snowbasin on Saturday, February 23rd with other Park City Mountain Sports Club (PCMSC) members. We were participating in a joint ISC and FWSA ski day. I joined the skiers, and my Peggy went snowshoeing with Barbara Maben.

It was a foggy day, but with brief periods of brighter light it wasn't all bad. That was the good part. We crawled our way down on the first run barely able to see the sides of each trail, but everyone made it successfully. We went up the John Paul Lift for the second run, starting down the bowl off to the left side of the lift. It had brightened up, so the surface of the snow could actually be seen.

About a fourth of the way down, we were skiing through some scattered trees; the snow was good and we had no problems. This was the end of the good part. As I skied around trees aiming for an open spot, I spied a sinkhole about 100 feet wide and 30 feet deep off to the left. The sides were steep and I didn't want any part of it, so I tried turning to the right to evade it. It didn't work. I slid on some ice, veered left and buried my ski tips in the rim surrounding the depression.

At this point, I came out of my skis and was catapulted into the sinkhole. Upon impact, my right arm jammed my shoulder and I could feel the joint separate. I slid most of the way down the hole and stopped with my arm sticking out at right angles to my body. I couldn't move it.

Fortunately, Norman Bates and others in our group, including Joe Coles, Don Anderson, and Randy Lew determined all was not well and summoned the ski patrol. Eventually they arrived, managed to brace my arm, and prepared to extricate me from a very difficult position in the hole. The ISC skiers I was with prepared a trail to higher, flatter ground, and then helped six ski patrollers get the sled out without dumping me. They did a great job. Next was the ride down the mountain to the clinic. This was rather scary because my bad arm was sticking out and I could just imagine hooking a tree, skier. All went well, and we arrived at the clinic about an hour after the disaster began. The next hour was not to be remembered. The staff doctor and an assistant spent the hour trying to get my shoulder put back together without anesthesia. You can imagine how much fun it was. I was ready to call it quits and go to Ogden to be drugged up when Peggy said a brief prayer and miraculously the shoulder slid into place. The pain was gone.

What lessons were to be learned here: (1) Don't ski in dense fog or even thinner fog, especially on a mountain that has not sbeen skied by many others. (2) Appreciate the ski patrol. The guys at Snowbasin were incredible from start to finish. (3) Ski with great people who will stick around even when told to go ski pther mountians. This includes the ISC group I skied with this day and all the PCMSC groups I've skied with in the past. (4) Don't ski into a big sinkhole and dislocate your shoulder.
