





**Speaker:** Todd Hood

Todd believes that the experience as a ski club or council member is built on love. The more value your organization delivers to your members, the more they love you. And when they love you, they glow when they think of you. They smile when they hear from you. They tell others what they love about you. And they forgive you when you fall short of their wishes, hopes and desires. The magic of strengthening your organization is "Making Love to Your Members". This hands-on session will give attendees the opportunity to work together to develop Love Plans to meet eligible lovers, seduce them into dating your organization, and making them literally fall in love with you. Todd Hood has been a member of the Snowbusters Ski Club of Pasadena since 1991, and is currently the Vice President of Membership for the Los Angeles Council of Ski Clubs. He also serves as the Operations Improvement Chair of the Western Region of the National Brotherhood of Skiers, where he serves as Treasurer. He is a graduate of Purdue University with a degree in Industrial Engineering, and received an MBA in International Finance at the Marshall School of Business, University of Southern California.

Convention Keynote Speaker . Charlie Linville

On January 20, 2011, while conducting a sweep of the surrounding area, Sergeant Charlie Linville was struck by an IED that blasted him into the air and brought him directly down into the blast crater. The explosion inflicted multiple injuries on Sergeant Linville, some visible, others not. Charlie lost his foot to a below the knee amputation the summer of 2013, after fighting for over a year to save it. In spring of 2014, he agreed to come on board with THE HEROES PROJECT to climb Mt. Everest. The climb was halted in April 2014, after 16 Sherpas lost their lives in an avalanche and again on their second attempt in April 2015, after the earthquake in Nepal. On May 19, 2016, Charlie completed the last of The Seven Summits, and became first combat-wounded veteran to reach the top of Mt. Everest.

Kyle is the owner of Sun Valley Ski Tools and sells high performance snowboard tuning equipment and logo apparel. Dave Hall of Race Works sells high performance alpine ski gear, ski tuning equipment, snowboard and ski wax, winter apparel for skiing and ski racing and alpine race gear. Chuck Cremer of McU Sports will talk about boot fitting, with a focus on the difference between a good and poor fit.



# Charlie Linville

Thomas Charles Linville was born in Boise, Idaho on August 22, 1985. He is the youngest and only son in his family. He has three sisters, Elizabeth, Brooke, and Heather. Charlie graduated from Boise High School in 2004 despite the challenges he faced when his father was diagnosed with stage four Non-Hodgkin's Lymphoma during his Freshman year of high school.

Eager to pursue his aspirations of serving in the United States military, he enlisted in the Marine Corps and attended boot camp at Marine Corps Recruit Depot San Diego, California on January 22, 2006.

After graduating boot camp he attended the School of Infantry at Camp Pendleton in May 2006. Sergeant Linville married his high school sweetheart Mandi on August 26, 2006.

Having successfully completed SOI training, Sergeant Linville became a 0351, Assault Man. He was stationed temporarily with 3rd Battalion 1st Marines, and shortly after found his home with the Marines of 3rd Battalion 5th Marines as the 0351 Section Leader.

After completing successful deployment preparations, Sergeant Linville deployed to Fallujah, Iraq, from September 2007 to April 2008, just two weeks after the birth of his first daughter Taylor.

During his combat tour he was meritoriously promoted to corporal for actions taken while conducting infantry operations. While serving in Iraq, Sergeant Linville occupied the role of Non-commissioned Officer in Charge of Observation Post O'Haire, and was one of three patrol leaders for mounted security missions within the company's area of operation.

Charlie returned from Iraq and decided to pursue his interest in explosives further. He submitted a lateral move to change his Military Occupational Specialty from 0351 Assault Man to 2336 Explosive Ordnance Disposal Technician. While awaiting orders to attend Naval School of Explosive Ordnance Disposal at Eglin Air Force Base, Florida, Sergeant Linville completed on the job training at Base EOD at Camp Pendleton, California. Once he completed On the Job Training duties at the base shop, he received orders to NAVSCHOOL EOD, where he reported in on March 26, 2008. Upon comple-



tion of NAVSCHOOL EOD on November 13, 2009, Charlie received orders to 9th ESB 3rd Explosive Ordnance Disposal Company on Camp Hansen in Okinawa, Japan. Two months before deploying, Charlie and Mandi delivered their second daughter Dyllan on August 5, 2010. He left for Helmand Province, Afghanistan, in October of 2010, where he was in direct support of 2/9 Echo Company in Marjah.

Sergeant Linville was placed with a new EOD team and continued operations in Sangin. While working with his new team, Sergeant Linville disarmed a multitude of IEDs. On January 20, 2011, Sergeant Linville and his team were responding to an IED detonation. While conducting a sweep of the surrounding area, Sergeant Linville was struck by a tertiary device.

The IED blasted Charlie into the air, and brought him directly down into the blast crater. The explosion inflicted multiple injuries on Sergeant Linville, some visible, others not. Sergeant Linville suffered fractures to his right foot including his cuboid, calcaneus, and two outer metatarsals, in addition to fractures sustained in his right middle finger, and amputation of his right ring finger.

Other injuries that resulted from the blast include lower spine trauma, PTSD, and mild traumatic brain injury. After

Charlie was medically evacuated he was flown to Bastian Medical Center where he underwent surgery on his hand. Next Sergeant Linville was flown to Bagram Air Force Base where he underwent additional surgery on his hand.

Once Charlie was flown out of Afghanistan, he went to Germany for three nights. He then flew to Bethesda, Maryland, for a night and finally reached his destination at Balboa Naval Hospital where he received multiple surgeries on his hand and foot.

Charlie has undergone multiple experimental surgeries in order to walk again. He continues operations and therapy on his foot and back in order to walk, sit, and stand without the IDEO brace and other supports etc.

Charlie lost his foot to a below the knee amputation the summer of 2013, after fighting for over a year to save it.

In spring of 2014, he agreed to come on board with THE HEROES PROJECT to climb Mt. Everest. The climb was halted in April 2014, after 16 Sherpas lost their lives in an avalanche, and again on their second attempt in April 2015, after the earthquake in Nepal.

On May 19, 2016, Charlie completed the last of The Seven Summits, and became first combat-wounded veteran to reach the top of Mt. Everest.

# Erik Fisher

Erik Fisher is a natural athlete. Whether he's skiing, kiteboarding, or playing football, Fisher can do it better than most. Scouting reports say he would have done very well in football at the NCAA level.

On the verge of a World Cup breakout season multiple times, 'Fish' has been constantly hampered by injuries, but that hasn't stopped his all out search for speed.

Back at it after missing all of 2013, Fish returned to his favorite World Cup hill and posted an impressive 13th in the Val Gardena, Italy downhill. It was enough to land a coaches' discretionary pick to the 2014 Olympic Winter Games.

In Sochi, destiny was in his own hands in the form of an intra-squad race-off for Team USA's final downhill starting spot. Steven Nyman ultimately won the spot.

Undiscouraged by a minor knee injury, Fish pushed through the remainder of the 2014 season. He raced the Spring

Series until the bitter end in hopes of improving his start position for the 2015 World Championship year, when the big event returns to American soil at Vail/Beaver Creek.

## FIRST TRACKS

Fisher was skiing with the Bogus Basin Ski School Program at age three. He was so bored waiting for all the other kids during his first lesson that he left the group and skied to the bottom alone, creating an all-mountain search by his instructors. When found, he was scolded and transferred to an older class for further instruction.

He picked up racing with the Bogus Basin Ski Racing Alliance at age seven and was named to the U.S. Development Team in 2004 while still a student at Rowmark Academy in Park City.

## OFF THE SNOW

Fisher has a diverse portfolio. He opened a shaved ice stand in his hometown during the spring of 2012 and has started many other small busi-



nesses. Off the books, he grew up playing football and baseball until his ski-racing career conflicted with too many games and practices. He was also a big fan of motocross until a crash fractured his leg in five different places. Now he's big into kiting, wakeboarding, ice hockey, road cycling, whitewater kayaking,

# Holt Haga



Holt Haga competed on the US Freestyle Team for five years, winning the moguls at the 2007 U.S. Freestyle Ski Championship.

Haga first hit the bumps competitively in his early teens with Idaho's Bogus Basin program. He harvested his skills in Idaho through his teen years, before making the decision to move to Park City in his 20's for the training environment at Utah Olympic Park. Wasting no time, Haga quickly racked up a national title at the age of 23.

Haga, although faced with nagging injuries, put forth an admirable career, competing on the World Cup and NorAm Cup circuits and in FIS races.

His most notable World Cup results came in 2008 when he scored two seventh place finishes at Lake Placid, NY and Mont Gabriel, Quebec. He also became a top NorAm Cup competitor standing on the podium several times.

Since retiring from the team in 2010, Holt has already turned the page, starting a new chapter. He is currently enrolled at Westminster College, piling on the credits with hopes of graduating within the year. Haga has focused his academic career in the world of finance, double majoring in Economics and Finance. Upon graduation, Holt hopes to move to a city where he can climb the career ladder.

# Alan Alborn



Alan Jacob Alborn (born December 13, 1980 in Anchorage, Alaska) is an American former ski jumper. At the 2002 Winter Olympics in Salt Lake City, he finished 11th in the team large hill and 11th in the individual normal hill events.

Alborn's best finish at the FIS Nordic World Ski Championships was 23rd in the individual normal hill event at Lahti in 2001. He finished 32nd in the individual event at the 2002 Ski-flying World Championships in Harrachov.

Alborn's best individual World Cup finish was fourth in a large hill event in Switzerland in 2001. His best individual career finish was second twice in lesser events (2001, 2004).

He held the North American distance record with 221.5 meters (achieved in Planica in 2002) until it was broken by Kevin Bickner in 2017.

Alan is now the Women's Ski Jumping USA head coach.

# Laura Sankey

As WSJ-USA's new president, Laura Sankey, Steamboat Springs, also brings a deep connection to ski jumping. Her daughter Logan Sankey was one of WSJ's first Fly Girls and is now a rising star on the national team with an upcoming spot in Junior World Championships and Youth Olympics.

Laura brings a passion for people, ideas, and sound strategy with a successful career in brand building, sales and marketing strategy. Her extensive corporate experience includes training at Procter & Gamble; and leadership posi-

tions at Coors Brewing Company, Qwest Communication (now Century Link), and the Green Bay Packers. Laura also has experience in the outdoor retail and technology industries.

Laura comments on her new role, "I'm honored to be involved with this dedicated and committed team of athletes, coaches and volunteers. The vision that started Women's Ski Jumping USA is incredibly powerful – and the achievements that have been realized are amazing; but this is a story that is still unfolding with heroines that are just learning to fly – I'm excited to ensure there are many thrilling chapters ahead."

# Sarah Hendrickson



Sarah Hendrickson is one of the most decorated female ski jumpers in history. The 22-year-old has 25 world cup podiums to her name, including 13 wins.

Hendrickson was the 2013 World Champion and in 2014 became the first woman ever to jump at the Olympics.

Sarah's 2011 World Cup victory in

Lillehammer made her the first woman ever to win a World Cup ski jumping competition. She is the youngest skier ever named to the U.S. Nordic team.

She was a bronze medalist at the 2010 Junior World Championships (first American, male or female, to win a medal at Juniors), she took sixth-place overall on the 2010 COC.

She won a Continental Cup victory in February 2009, and a second-place finish in the K120 at the 2008 and 2011 U.S. Championships.

Sarah was on skis at age 2, and both her father and older brother are involved in jumping. Sarah is also a talented soccer player, loves alpine and tele skiing and likes to ride her unicycle. She has picked up motherly tasks such as suit sewing skills, and she is always making sure her teammates have what

they need. They've started calling her the "Team Mom."

## 1964 Olympic Slalom Silver Medalist



When you think of legends in American skiing the name **Billy Kidd** is at the top of the list. He and teammate Jimmie Heuga became the first American men to win Olympic medals in alpine skiing — a silver for Kidd and a bronze for Heuga in the slalom at Innsbruck, Austria.

Although his racing is confined mainly

to the "Legends Races" now, he continues his involvement in the sport as Director of Skiing at Steamboat; TV commentator at the Olympics; Head Skiing Coach for Special Olympics as well as equipment design, books, videos and movies.

Kidd grew up in Stowe, Vermont and raced internationally for nine years on the U.S. Ski Team. While racing, he studied at the University of Colorado and graduated in 1969 with a degree in economics.

In the 1964 Olympics, Billy marked yet another "first" for American men by becoming the first person to win both Amateur and Pro World Championships in a single year-1970. Kidd went on to win the Amateur World Championship in Val Gardena, Italy. Then Billy turned pro and two weeks later won the World Pro Championships.

Billy has made his home Steamboat Springs, Colorado since 1970 and spends much of the winter as Director of Skiing at the Steamboat Ski Area and running his Billy Kidd Performance Center.

Billy also leads Steamboat's Ute Future Olympian program, which brings Native American youngsters from Utah reservations to Steamboat, where they build self-confidence by learning to ski and snowboard. His efforts with Native American youth earned him the Texaco Star Regional Award.

Because his Olympic teammate and long-time friend Jimmie Heuga had MS, Kidd is also involved in fundraising for Multiple Sclerosis and is on the board of directors of the Jimmie Heuga Center for the Reanimation of the Physically Challenged, now known as Can Do MS.

# Sandy Chio

The Squaw Valley Ski Museum Foundation recently announced that Sandy Chio has joined the organization as Executive Director.

Sandy comes to North Lake Tahoe from Park City, Utah, where she led the marketing and communications team for the Utah Olympic Legacy Foundation, a non-profit created as part of the 2002 Winter Games in Salt Lake to maintain and preserve three important legacy venues: Utah Olympic Park in Park City, Utah Olympic Oval in Kearns, and Soldier Hollow Nordic Center in Midway.

The Utah Olympic Legacy Foundation, one of the world’s most successful Olympic legacy business models, lever-

ages public programming revenues, individual donations and public-private funding to subsidize the expenses of winter sports programs, athlete training and competitions.

For the past seven years, the Squaw Valley Ski Museum Foundation has been working with public and private partners to identify a site and to build a museum that celebrates the impact of the 1960 Olympic Winter Games on the greater Tahoe region.

The museum also plans to recognize skiers, snowboarders and ski area pioneers who have influenced western winter sports since the time of the California gold rush. The Squaw Valley Ski Museum Foundation Board believes in



the importance of preserving and sharing local heritage with residents and visitors, as reported in studies conducted by the California Office of Tourism and North Lake Tahoe Resort Association.

# Dave Ludwig

## Founder, Hope on the Slopes

Dave Ludwig, founder of *Hope On The Slopes (HOTS)*, states in his own words "The inception of what is now the American Cancer Society *Hope On The Slopes* began as an idea or thought while riding the chair one day at White Pass. In those days, White Pass had a RFID vertical tracking system that I enjoyed using. We could track our runs and vertical for the day and the year to date. My thought at the time was "how could this be used as a fundraiser"?"

Since this early concept phase, White Pass has helped develop and refine *Hope On The Slopes*, and has been involved in the expansion of the event to almost every new location.

Since inception in 2002, **over \$2.5 million has been raised by Hope on the Slopes** for the American Cancer Society.

In 2011 Dave founded *Ski & Ride For A Cure*, a 501(c)3 organization, the purpose of which is to expand *Hope On The*

*Slopes* to ski areas and resorts where the ACS did not have budget or trained staff. This grew into an agreement with the ACS to transfer the *Hope On The Slopes* events in the West to the new non-profit. The American Cancer Society remains the beneficiary of funds raised.

In its first season of operations for *Ski & Ride For A Cure*, the team managed the transition of the seven *Hope On The Slopes* in the West (Breckenridge, Silverton, Ski Bowl, Mt. Spokane, Stevens Pass, Crystal Mountain, and White Pass). In total, these fundraising events were supported by approximately 1,500 volunteers, and raised over one-quarter of a million dollars.

About 12 million people living in the United States today have had some type of cancer. Half of all men and one-third of all women in the U.S. will develop cancer during their lifetimes. The funds raised for the American Cancer Society



through *Ski & Ride For A Cure* go to research, early detection, patient services and support.

Through *Ski & Ride For A Cure* we now have an opportunity as an industry of resorts, volunteers, and business supporters to make a difference in the fight against cancer.

This is Lindsey's regimen, and she encourages people to take from it what will work for them. She bounced back


from injury not by doing every single thing a trainer said, but instead, by thinking about the fitness plan that would work for her, and eating the right foods that would make her feel and get healthy.

## Warren Miller Modern Media Award Travis Rice and Brain Farm Cinema for “The Fourth Phase”



This film been in production since 2013, but Travis Rice's long-awaited snowboarding film was finally released in October 2016. We got a first look at it when a trailer dropped last year, but in the most recent teaser, *The Fourth Phase* positions itself as less of an epic and more of a documentary. Present in both, however, is the same mantra: this process we follow, this cycle we ride. Synopsis: In short, the crew of old- and new-guard riders follows winter as it creeps across the globe. You'll see landscapes that populate every powder hound's dreams; the film follows Rice across a 16,000-mile pursuit of the

“hydrological cycle around the north Pacific... from the Japanese Alps to the volcanoes of Russia, and a spectacularly remote area of Alaska,” as the film's official description puts it. “The film we're making right now is the film I always wanted to make,” Rice says. “We've just been able to take a little more time—this isn't a strike mission to the goods, to grab and plunder and make away with a couple good clips.”

## Bob Greenwood


### Skiing is a Lifetime of Fulfilling Activity

Bob Greenwood arrived in Boise in 1950 with his degree in Physical Education from WSC (WSU from 1959), earned on the GI Bill for his Navy service in World War II. This was the start of the Bob Greenwood of Boise.

Bob's passion and drive over the next four decades have made an indelible impact on the development of recreational skiing at Bogus Basin and regionally.

Bob had some experience in the university ski shop and recreational racing. So when he arrived in Boise, he took jobs in several ski shops in the 1950s until he opened his own tiny store in 1957 – Greenwood's Ski Haus. And it continues today, albeit after several changes of ownership and location.

Bob operated the Ski Haus through 1985, and it and his relationships had a



regional influence in equipment sales. What started in tough times became good times as skiing became a mass recreation.

Concurrent with his employment in ski shops, Bob started with the Bogus Basin Ski School as an instructor. Bob taught skiing for a quarter century through 1976, and for much of this time he was part of a traveling team of PNSIA examiners. His territory went from Sun Valley to all the big Washington and Oregon resorts near the west coast.

In 1985, Bob started what he called the Prime Timers, a group he invited to Bogus Basin to make some tension-relaxing afternoon runs. The only qualification is that the skier had to be at least aged 50. In those days, he often

greeted medical personnel on their Wednesday afternoons. Bob still skis with the Prime Timers at 91 years young, although he has passed the lead of the program.

Both Bob and his wife Dottie, whom he married in 1958, are life members of the Bogus Basin Ski Club and emeritus members of the Bogus Basin Recreation Association.

Bob Greenwood, by leadership and example, has made an indelible impact on the development of skiing at Bogus Basin and regionally as well. He is also an emissary for the life-enhancing values of outdoor living and sports, especially golf and skiing, always skiing.

# Snowsports Builder Award

## Nancy Ingalsbee

### From Volunteer to Skiers' Voice in Washington DC



Skiing and skiers were under great pressures in the 1965–1985 era due not only to the immense increase in popularity of skiing but also from political action and litigation by environmental activists. Environmental activism created a long, bruising battle that mobilized FWSA members, clubs and councils to their highest level – and not experienced since.

The skiers' battle became focused on the Disney proposal for development of Mineral King. But Mineral King became the poster child in the battle for skiing.

Nancy opened a Washington office for FWSA in May 1978 and a new USSA/Sports Government Relations office on Pennsylvania Avenue in June 1981. Except for Inaugural duties for incoming President Ronald Reagan, she served as the principal Washington voice for skiers' interests for nearly ten frenzied years. She became a go-to expert in Washington on skiing matters for many agencies and political figures.

Our honoree is the former mayor of

Allegan, Michigan. In an extraordinary set of actions, she took the initiative to do something about a significant threat to the future of skiing. She started her campaign in her own ski club, Balboa, and in 1977 the Southern Council and San Francisco ski shows.

She produced the world's "longest letter" to the Forest Service - and whoever else would listen - to proceed with the development of Mineral King. She had no expense money, so Balboa members raised \$632 to send her to Washington with her letter in September 1977. Later, thanks to a generous donation from Disney to fund Nancy full time, she commenced flying into Washington regularly.

She had evolved from club activist to Association committeeperson and then to full time as Director of Public Affairs in October 1977. During this time, the Sierra Club sued the Forest Service over its environmental impact assessment for Mineral King. The suit ultimately reached the Supreme Court. FWSA and others had filed an amicus curiae brief in favor of skiing.


The suit failed. But then came legislation to put Mineral King into Sequoia National Park. This would kill Mineral King for skiing, because the Park Service does not allow lift-served skiing on park lands.

But we started too late; Mineral King went into Sequoia National Park October 16, 1978. One of California's Senators defected and the transfer was made. It is considered by many skiers to be the mortal blow that ended further expansion of skiing in California.

But there remained a further significant threat to terrain identified as suitable for skiing and the RARE II (Roadless Area Review and Evaluation) by the USFS was that threat. Nancy and the California Public Lands Coalition (Nancy was the organizer) systematically identified ALL potential ski terrain in roadless areas in California as identified by the Forest Service itself.

Provisions were then drafted to exclude ski terrain from unfavorable land use decisions that would be made on the basis of the RARE evaluations. And this systematic approach became a template for other regions. Her efforts benefited both the future for grass roots skiers as well as that for ski area expansions.

We hope there will never again be another battle with our fellow environmentalists, nor the mobilization of our own members. We are unlikely to see the likes of Nancy Ingalsbee again. She is a star in our western skies. She was a major force in preserving the possibilities for future skiing on public lands. And she made skiers a force to be recognized. Salute her during your runs and raise a toast to her après ski.

Every fourth year is a key year for snowsport. This is the final training year for USA athletes to prepare for the Winter Olympics in Pyeong Chang, South Korea, this coming February. They, the up and coming aspirants, and the organizations who support them, deserve your special attention.

The Far West Ski Foundation – YOUR Foundation - is ready to help lessen any discomfort you may have about contributing your resources to snowsport. We offer a tax-deductible avenue for your support to reach three or four snowsport objectives.

If your focus lies in Olympic competition, go no farther than women's ski jumping. Our leading lady jumper, Sarah Hendrickson, is with us at this June meeting to promote the cause – and also a Foundation mission – for women's ski jumping. This is in the highest tradition set by the sport's late president and greatest advocate, Deedee Corradini.

The four missions of the Foundation are to support Alpine ski racing, disabled skiers, women's ski jumping and education.

But let's not stop with international competition. We also support U21, U19 and second year U16 junior ski racers. These are the young people who will go on to become community leaders as well. Trustee David Krupp's Athletic Scholarship Program article has more information on this program.

While the ski racers are the able, we must continue doing

our small part toward enabling the disabled. Among the broad spectrum of disabilities among both young and old, there is a dream of outdoor participation in sports and recreation. Included in this population is a remarkable set of heroic persons injured in war.

All would benefit from rehabilitation leading to the ability to do adaptive skiing. We'd like to do more, but we strive at minimum to make modest helping grants to both a disabled ski school and a "wounded warrior" activity. Our wine auction is devoted to supporting adaptive skiing. Wine is donated by Joe Harvis and Trustee Gloria Raminha and the silent auction is operated by them and their assistance.

And if education is your interest, as well it should be, the Far West Ski Foundation also attempts to augment the support for museums. We are especially interested in the Squaw Valley Ski Museum Foundation. This museum at the site of the 1960 Winter Olympics will include all winter sports and a heritage center as well. Honored guest Sandy Chio is with us; she is the Executive Director of the SVSMF and has much more to say about it.

## Athletic Scholarship Program

The Far West Athletic Scholarship Program, now in its 13th year as a means of making a positive contribution to junior racing, has continued to garner more support each year.

Since 2004, the FWWSA has awarded 104 scholarships for a total of well over \$100,000. In 2016, FWWSA awarded 14 scholarships totaling \$13,750. We express our thanks to our sponsors, Whitefish Mountain Resort, Grouse Mountain Lodge in Whitefish, Schure Sports, maker of the Karbon line of snowsports clothing, and Far West Racing Association. We would also like to thank our partners, Skiyenti Ski Club, Mountain High Snowsports Club, Castro Valley Ski Club, Los Angeles Council of Ski Clubs, San Diego Council of Ski Clubs, Northwest Ski Club Council and Sierra League and Council. Finally, a special thanks to all the Far West members who have so generously contributed to the program.

United States Ski Association licensed junior racers in the U21, U19, and second year U16 classes in states represented by FWWSA affiliated councils are eligible for a scholarship. This year, junior racers in California, Nevada, Arizona, Oregon, Washington, Idaho, Utah and Wyoming are eligible.

Scholarships are awarded on the basis of financial need, competitive accomplishments, academics, and community service. National ranking in competitive skiing can cost well in excess of \$10,000 per season; a financial challenge for even upper middle class families. The need is great and we

anticipate that the number of applications will continue to increase.

Convention attendees have the opportunity to support the Athletic Scholarship Program by participating in the auction of a ski and stay package donated by Whitefish Mountain Resort, the silent auction of lodging at the beautiful Grouse Mountain Lodge in Whitefish, and finally, our raffle featuring an assortment of great prizes including apparel donated by the U.S. Ski Team.

Raffle tickets cost \$5 each or five for \$20. All funds for the scholarship program are deposited with The Far West Ski Foundation, an IRS 501(c)3 charitable foundation, that was incorporated as a partner of FWWSA to provide a means of accepting contributions. The foundation qualifies contributions to the scholarship program as income tax charitable deductions.

# Awards Program

In a volunteer organization such as Far West Ski Association nothing happens without individuals contributing their time and talent to produce programs. These dedicated people could never be compensated for the contribution they make to the association. For volunteer organizations, recognition is the most valuable thank-you that can be offered. In many ways the maturity and stature of an organization can be measured by the value that individuals place on the recognition program. Far West has one of the broadest programs of any regional ski association in the country and there are many opportunities for aspiring individuals, clubs and councils to gain recognition.

The modern day Awards Program was initiated in 1966 and has witnessed a series of expansions and changes over the years. For 2007, optional electronic submissions and voting has been added to the Far West Service awards. The Charity and Community Service Recognition Award for Clubs and Councils was added in 2007. Historical recognition for clubs and councils was added in 2008. In 2008, under the direction of John Watson, the Snowsports Builder Award was initiated. The Environment Award was added in 2015.

There have been a number of changes to the Club and Council Recognition Awards since 2015. The intention is to bring awareness to our programs and make the awards easier to apply for. This year all application forms were again standardized and fillable electronically. The Communications Awards continue to be done through online or email submittals and were modified again in 2017.

### **I. Far West Service Awards**

The Far West Service awards, sometimes referred to as “The Great Eight” are administered by Catherine Ohl, Awards Chair, with a committee consisting of Jane Wyckoff and Steve Coxen. Use of the Internet continues to be the popular and a most efficient means of submitting nominations and voting. Voting was permitted using the Internet, email or by the traditional snail mail. These awards are given to individuals or a team within the Far West Ski Association or Ski Industry. All accepted citations are archived at the Western SkiSport Museum in Boreal, California as a living history of volunteerism in the Far West Region. In addition to commemorative plaques and medallions, a permanent display of past recipients is showcased at the Museum. The Museum is administered by the Auburn Ski Club (<http://www.auburnskiclub.org/>), one of the founding ski clubs of the Far West Ski Association.

#### **Hans Georg Award (1966 - present)**

The Hans George Award is given for distinguished accomplishment and long-term contribution to snowsports. This award is given to an individual or individuals who have contributed significant achievements to snowsports, not necessarily organized snowsports. It reflects a long term contribution and is the highest award of the Far West Ski Association. This award may only be received once and is based on a ten-year minimum service in the Far West region.

#### **Elizabeth 'Schatzi' Wood Award (1966 - present)**

The Elizabeth Schatzi Wood Award is given to the woman, in the Far West region, who has, through efforts in ski club, council, region, national or international activities, made a decisive contribution to snowsports during either the past year or in a prior year This award may only be received once and is based on one or two year achievement (not long-term service) in the Far West region. The two years of service can be for prior years, not just the past two years.

#### **Award for Outstanding Club and Council Web Sites**

The Award for Outstanding Web Site is administered by Paul Vlasveld and Cindy Krupp, under Jo Simpson, FWSA VP Councils. Each club and council is asked to submit their web site URL for judging.

Club awards for the Tollakson, Wentworth and Outstanding Web Site are presented to clubs based on their performance over the past four years that can vary slightly from year to year. A club may fall into a different class in each of the three categories.

<b>Masters:</b>	Any club that has received a 1st place Advanced award or a 1st, 2nd or 3rd place Masters award for their club for outstanding club, publication or website within the last four years.
<b>Advanced:</b>	Any club that has received a 1st place Novice or a 2nd or 3rd place Advanced award for their club for outstanding club, publication or website within the last four years.
<b>Novice:</b>	Club who has not won an award in the past 4 years or a 1st place Novice award.
<b>Council:</b>	Open to all councils

### **5. Recognition Awards**

#### **Councils' Man & Woman of the Year**

The Councils' Man and Woman of the Year Competition is administered by Gene Fulkerson, under Jo Simpson, FWSA VP Councils. Each council is requested to submit a man and/or woman candidate who best represents their council. In addition, each council is required to submit one judge to help with the judging.

This award is presented to both an outstanding man and woman at the grassroots level. Selection criteria is based on each individual's involvement in snowsports; club, council, regional and national activities; and knowledge and enthusiasm for the snowsports. Candidates should have awareness of Far West programs and, in particular, its public affairs involvement. Emphasis has been shifted to Club leadership over the past ten years.

The Councils' Man and Woman of the Year is sponsored by Big White Ski Resort, BC, Canada since 2001.

### **Safety Person of the Year Award**

This award is administered by Richard Lubin, Safety Chair, under the leadership of Mike Sanford, VP Public Affairs. This award honors the person within FWSA who does the most to promote safe snowsports and safety programs at the club and/or council level. Individuals are judged through the utilization of organized events, educational forums, print and electronic media, on mountain activities and partnering with other, safety focused community and industry organizations.

The Safety Award has been sponsored by Telluride Ski Resort and Mountain Lodge Telluride since 2015.

### **Western Ski Heritage Prize**

This award is administered by John Watson, History Chair, under the leadership of Mike Sanford, VP Public Affairs, and recognizes an outstanding effort in the area of ski history by historians in the identification of resource material, preparation of historical publications and/or recording or documenting of significant historical events. This award also recognizes interest in Far West's history through collection, preservation and protection of appropriate articles and material. ### **Environment Award**

### **Charity and Community Service Recognition Award**

The winning clubs receives a \$200 donation to the charity of their choice. Second place club winners will receive a \$50 donation to the charity of their choice. First place council each receive \$100 donation to the charity of choice.

### **Council Challenge**

The first Council Challenge was held in Mt. Bachelor when the Bay Area Council challenged the Northwest Council (then known as Portland Area Ski Club Council) to a duel race. Teams consisted of the best 6 racers from each council. In Steamboat the Challenge was opened up to all councils. In a surprise move, Arizona beat out Northwest, Bay Area and Los Angeles. Today teams consist of 8 racers from each council and must be a mix of men and women. And if you can't beat them on the course, your team can compete for the best costume.

### **Racer of the Week**

Awarded to the female and male racer who earns the most points for the Slalom and Giant Slalom races at the FWSA North American Ski Week. This award is administered by the Far West Ski Association's Ski Week Staff.

### **Far West Championships**

Awarded to the Far West race league that earns the most points overall at the Far West Championships. The Far West Racing Association administers this award.

### **Roma McCoy Trophy**

Awarded to the Far West race league that earns the most points per racer start at the Far West Championships. The Far West Racing Association administers this award.

Responsibilities for the Industry Marketing Program include: producing the Silent Auction and Travel Expo, sponsorship development, serving on the Convention Committee, and promoting advertising sales for the Far West Skier's Guide. Debbi Kor, FWSA Vice President of Marketing, is responsible for the membership benefits program and product sponsorship development. Jeannine Davis is Chairman of the annual Silent Auction and Fran Long is the Travel Expo Coordinator. Leigh Gieringer is Editor of the Far West Skier's Guide. The ski industry invested over \$142,000 this year in Association industry programs.

#### Silent Auction

In 2017, we are celebrating the 85th Annual Convention, and the 32nd Silent Auction. FWSA truly values the working relationship our Association has developed with the ski and sports industries. Countless hours have been spent by dedicated ski club, council and FWSA volunteers, who assist with conducting a successful Silent Auction, each and every year.

The Silent Auction began back in 1986 at the Irvine Hilton and Towers, when the Balboa Ski Club of Orange Council of Ski Clubs, host for the 54th Annual Convention, organized the event as a fundraiser to be held in conjunction with the Convention. In 1990 the Travel Carousel was added to the industry Convention programs at the 58th Annual Convention, hosted by the Orange Council of Ski Clubs, when the Association returned to the Irvine Hilton. The format remained the same until the 2003 Convention held at the Rancho Las Palmas Marriott in Rancho Mirage, California, hosted by the San Diego Council of Ski Clubs. The Travel Carousel became the Travel Expo, and Passports replaced the Lift Tickets. Convention delegates now schedule appointments with industry representatives, meeting one-on-one in a timed sequence. Each year we look forward to seeing our industry friends at our Annual Convention, some of whom have attended for thirty years, and others who are brand new to our program.

The Silent Auction is the Association's major fund raising effort and not only provides financial support for our programs, but also subsidizes delegate fees to the Convention. The Silent Auction and Travel Expo would not be possible without the assistance of many special people – many thanks go to this year's Hosts, Bogus Basin Ski Club and Intermountain Ski Council, as well as the many volunteers who do all the behind-the-scenes work and setup. The "Convention Team", tasked with production of the Silent Auction and Travel Expo includes Jane Wyckoff, Convention Chair, Jeannine Davis, Silent Auction Chair, Fran Long, Travel Expo Coordinator, and Debbi Kor, V.P. of Marketing and Sponsorship and registrar for all of our industry partners. The team puts in countless hours to bring you an outstanding event for both club members and the industry. Our gratitude is extended to all the workers from the Intermountain Ski Council, Bogus Basin Ski Club, and the FWSA Board Members, friends and volunteers from other councils who assist with last minute preparations prior to the Silent Auction and Travel Expo.

The **FAR WEST SKI FOUNDATION** is the fund raising sister organization to the Far West Ski Association. FWSF was established in 1964 as a 501c3 organization to support training for Alpine racing in the 1964 Winter Olympics. It expanded on that mission in 2009 to raise funds and offer grants in four mission areas. These include scholarships for under-20 Alpine racers, scholarships and wounded veteran support to enable the disabled to enjoy adaptive snowsports, support

to women's ski jumping, especially scholarships for the development training of its Fly Girls, and support for the preservation in museums and historical snowsports, research for education regarding the contributions of snowsports to the cultural and sports history of the nation. Contributions are tax deductible and may be made to any FWSF Trustee or through PayPal, identifying your gift as directed to the Far West Ski Foundation. **Disabled Sports USA (DS/USA)**, with the motto "If I Can Do This, I Can Do Anything", was founded in 1967 by disabled Vietnam veterans to provide opportunities for individuals with disabilities to gain self-confidence, greater independence, dignity, and mobility through sports, recreation and educational programs. The organization is the nation's largest multi-sport, multi-disability organization serving more than 60,000 people nationwide. **Warfighter Sports**, formerly known as the **Wounded Warrior Disabled Sports Project**, is a part of DS/USA and offers 50 different sports rehabilitation programs in military hospitals and communities across the US through a nationwide network of over 100 community-based chapters. Programs take place at sites throughout the US, offering returning Warfighters the opportunity to integrate as participants and mentors in their home communities. **1,500 wounded veterans were served through this program last year.** Many Warfighters have returned home to our FWSA communities, and several of our councils and clubs have been including them in their chapter activities. FWSA clubs and councils have a long term relationship with several California Chapters of Disabled Sports USA: The Achieve Tahoe Adaptive Ski School at Alpine Meadows, the US Adaptive Recreation Center at Big Bear (USARC), The Unrecables Ski Club in Los Angeles, and Disabled Sports Eastern Sierra at Mammoth Lakes (DSES). **Special Olympics** relies on dedicated volunteers to provide year-round sports training and athletic competition in a variety of Olympic-type sports for people with mental retardation. With 220 offices world-wide, the Special Olympics global community includes athletes, volunteers, coaches, family members and sponsors/supporters. Research shows that there is an overwhelming consensus among Special Olympics athletes, coaches and family members that there is significant improvement in athletes' sense of self, social skills, and social interactions due to their participation in Special Olympics. Parents see health benefits that are critical, given the unmet health needs of people with intellectual disabilities. **CAN DO MS** helps people with multiple sclerosis gain health and hope. One in 750 people has multiple sclerosis, a devastating, neurological disease in which a person's immune system attacks the brain and spinal cord. There is no known cause or cure for MS. All of the Center's programs are based on the philosophy that you can have a chronic condition AND have your health. The Center's motto is "Be More Than Your MS". To honor their founder's positive spirit and legacy, Can Do MS has declared Jimmie Heuga's birthday, September 22nd, as CAN DO DAY. There's just something special while traveling in Austria and 43 FWSA members experienced this while skiing in St. Anton am Arlberg March 11-19, 2017.

Our members enjoyed the beautiful country of Austria, offering an amazing array of sights, sounds and tastes that pleased both skiers and non-skiers alike. St. Anton am Arlberg is considered one of the world's top ski resorts and après-ski destinations. We stayed at the beautiful 4 Star Schwarzer Adler Hotel which offered a full-service luxury property complete with Jacuzzis, pool and spa services. It is in the charming pedestrian zone and offered convenient ski storage at the base of the gondola. Our ski pass provided skiing at multiple resorts including: St. Anton, St. Christoph and Stuben, Lech, Zurs and more. This area is considered one of the "Best of the Alps" ski resorts and was appreciated by all.

We invited another ski group from Michigan, who also was working with Holiday Ski Tours to meet us for an Après Social at the Hotel Schwarzer Adler and to join us on our day tour to Vaduz, Liechtenstein. This was great fun to get to connect with fellow skiers, share stories and tell tales.

We were excited to take 26 people to Vaduz, Liechtenstein since that was a new destination for FWSA. Liechtenstein is the 4th smallest country in Europe, yet its Prince is the richest monarch in Europe. Vaduz has its own parliament in which the Prince is the head and has the power to sanction all new laws. It is a small country with enormous wealth, primarily from the financial business world, which means the way of life has changed from the simple life of farming as it was in years past. It was fascinating to learn that the Prince is self-supporting. He has farm land in the US, an enormous art collection and does not get money from the government. Budapest is divided by the Danube, where you have the Buda and the Pest sides. There are 155 thermal baths which offers therapeutic healing waters for those who enjoy them. 25% of their economy comes from tourism and we can see why as this is such a unique and popular travel destination.

On Friday evening, we had a delightful dinner cruise down the Danube. We had the entire boat to ourselves with a delicious spread of food. We had to stop and pinch ourselves from time to time and realizing that we were there, took in the spectacular views of the buildings lit up at night. ### **FEBRUARY 25—MARCH 4, 2018 IDITAROD/ALYESKA RESORT SKI TRIP**

Council representatives will take home their materials and ask for their council boards to review the information and submit their council's choices for the 2019 ski week.

A change this year is that tour operators will submit up to two proposals each and then one proposal will be selected from each tour operator to be presented during the morning bid presentation time. Skigroup.net; Ski.com; and Sports America Tours will each present one proposal.

The final selection will be made at the July FWSA Board of Directors' meeting.

# Public Affairs

The **National Ski Areas Association (NSAA)** recently released its 16th Sustainable Slopes Annual Report detailing the ski industry's progress in implementing the principles of its Environmental Charter. The report highlights results of industry's Climate Challenge Program, a voluntary program for resorts to inventory, target, and execute environmental improvements. In total, almost 200 resorts have endorsed the Environmental Charter over the past 16 years, representing over 75 percent of the ski resorts nationally by skier visits.

Also highlighted in the recent report is the **Sustainable Slopes Grant Program**, now in its 7th year of providing seed money and in-kind donations to support important ski area sustainability projects. Many Western ski areas were affected by these efforts. Four resorts are receiving grants this year: Arapahoe Basin, Colo., Copper Mountain Resort, Colo., Granite Peak, Wis., and Mt. Bachelor, Ore.

Since its inception in 2009, the Sustainable Slopes Grant Program has awarded \$123,500 in cash grants and \$359,000 in in-kind grants, for a total of \$482,500 in support of resort sustainability projects. **Protect Our Winters** has published a link to a new EPA study that estimates that we will lose about 30% of skier/snowboarder visits and snow sports revenue by 2050 due to climate change. The findings are alarming and potentially dangerous for the snow sports industry but there are some issues with the research and the conclusions regarding both the monetary impact of climate change and the viability of resorts at risk for abbreviated seasons.

This report uses resort data patterns established in the NSAA Kottke end of season report, Forest Service Use Survey data, various climate modeling tools and GIS data to pinpoint resorts and impacts on selected downhill ski and snowboard, cross country ski, and snowmobiling areas across the U.S. The number of days available for snowmaking is key to this analysis and opening day date changes are projected as well as change in the total number of days available for skiing, riding and snowmobiling. The news isn't good for the industry and resorts looking for financial backing may want to bury this report under a few tons of snow.

### **Snowmaking and Opening Day**

The report found that as of winter 2016/2017, 70% of modeled downhill skiing and snowboarding areas can reach 450 hours of total snowmaking by December 15th, but due to climate change, by 2050 fewer than 40% of areas would be able (with current technology) to make enough snow to open before the Christmas holiday. Note that representatives from several resorts that are shown to suffer most in this report said that 450 hours is a vast overstatement of the number of hours of snowmaking required to open.

I want to remind you all we have a number of fabulous awards available to our members on an annual basis. This should be highly publicized at all council and club levels.

# Racing

This year has been very interesting. A great year for snow in the Sierra's, as a matter of fact, it is a record year. The FWSA Ski Week at Breckenridge went fairly smoothly, we had nice firm snow to race on, cool weather, well set courses by the Breckenridge Race Department and many enthusiastic racers who enjoyed the competition. Many of the racers were very impressed with the run where we raced, as it pushed their limits to complete some of the courses. Overall, many racers had a great experience at Breckenridge.

This year at Breckenridge, BAC won the Lake Louise Award for most points by a council with 517 points, LA Council was second with 477 points, and Sierra was third with 460 points. In the race for the Joe Ross Award, the Cabernet Race Club from Truckee took first with 349 points, Rusty Bindings was second with 255 points and Aerospace was third with 212 points. In the Council Challenge Race, Orange Council took first with a total time of 350.15 seconds, Sierra I was second with 379.94 seconds, and BAC was third with 392.16 seconds.

In the local races in Tahoe and at Mammoth, racers were fighting mother nature all year long. Almost every local race experienced tough snow conditions this year. The inconsistent conditions made it difficult to put on quality race events, but that is what we attempted to accomplish.

Socals put on 4 GS races in one day in order to get their races in at Mammoth Mountain.

The Far West Championships were just completed at Mammoth Mountain with great enthusiasm from all competitors. The \$1,000 donation for the shirts from the Far West Ski Association at the event was well received by the Far West members. The Mammoth Race Department provided competitive well planned courses that were on-time with accurate timing.

Open League won the Junior Division hands down with total points of 257 and 21.41 points per racer for Juniors. In the Adult Division, Open League also swept the awards with first in overall points with 915, ULLR was second with 516 points, and San Diego was third with 465 points. The Roma McCoy Trophy was also won by Open League with 19.06 points per racer, Singles League was second with 17.25 points per racer, and San Diego was third with 15.50 points per racer.

Next year the Far West Championships will be held at Mammoth Mountain on in April 6-8, 2018.



